Accounts Payable

Vendor Lookups

The following field is available throughout the Accounts Payable Application. This field allows you to quickly locate a Vendor.

- 3. Lookup by:** Click to choose to have the window sort alphabetically by company name or by vendor number.
- 4. OK:** Click “OK” when you have selected the vendor you are seeking.

- 5. Cancel:** Click “Cancel” to cancel and return to the screen you were working in without selecting a vendor.

Accounts Payable

Cleaning up Open Purchase Orders

If you have open purchase orders that remain on your backordered report and you would like to clean them up:

1. Go to “8. PO/Requisition Menu” from the Main Menu, then go to “R. Reports Menu” from the Purchase Order/Requisition Menu.
2. Print “3. Backordered Goods” report.
3. Go back to the Purchase Order/Requisition Menu, and choose “1. Add/Edit Purchase Orders. ”
4. Enter a Purchase Order/Requisition Number from the Backordered Goods report.
5. Go to the “Items” tab and change the units to the actual received figure from the Backordered Goods report.
6. Save and Exit.
7. Go to the Main Menu.
8. Transfer the data to the General Ledger through “A. Transfer Data to G/L.”

Accounts Payable

Preparing an AP Warrant

1. Organize paper records (group invoices by Vendor and new GL account numbers).
2. Add any new GL accounts in “2. Account Maintenance” in the General Ledger Module.
3. Open Accounts Payable.
4. Add any new Vendors in “6. Vendor Maintenance” in the Accounts Payable Module.
5. Create a Restore Point through “H. Restore Points” off the Main Menu.
6. Enter in all new invoices using “1. Invoice Maintenance” off the Main Menu.
7. Go to “R. Reports Menu” and choose “1. Invoice Edit List.”
8. Choose to have this report show Un-paid invoices for All checking accounts. Leave the starting date empty and enter the ending due date being used for the current invoicing. Preview/Print the report.
9. Compare listing with current invoices entered and notice any invoices that appear due to voided checks or previous Payroll transfers. All these will be paid following these instructions.
10. If any need adjusting then use “1. Invoice Maintenance” from the Main Menu. Changing due dates to a future date or voiding an invoice are most common. A voided invoice number can not be used again.
11. **Accrual Accounting Only.**
 - I. Select “A. Transfer data to GL” from the Main Menu and print the report.
 - II. Go into the General Ledger Module, accept the transfer, compare the two reports you just printed.
 - III. Return to Accounts Payable.
12. Enter “2. Print Checks” from the Main Menu. Put Checks into the printer. Fill out the appropriate information, and print. **Do Not** answer any questions on the screen until printer is done printing. When the printer is finished, you will be able to select the option that best fits your situation. Take any leftover checks out of the printer and put normal paper in.
13. Go to “R. Reports Menu” and choose “3. Check Warrant” to print for signatures.
14. Choose “A. Transfer data to GL” off the Main Menu and print the report.
15. Go back into the General Ledger Module, accept the transfer, compare the two reports you just printed.

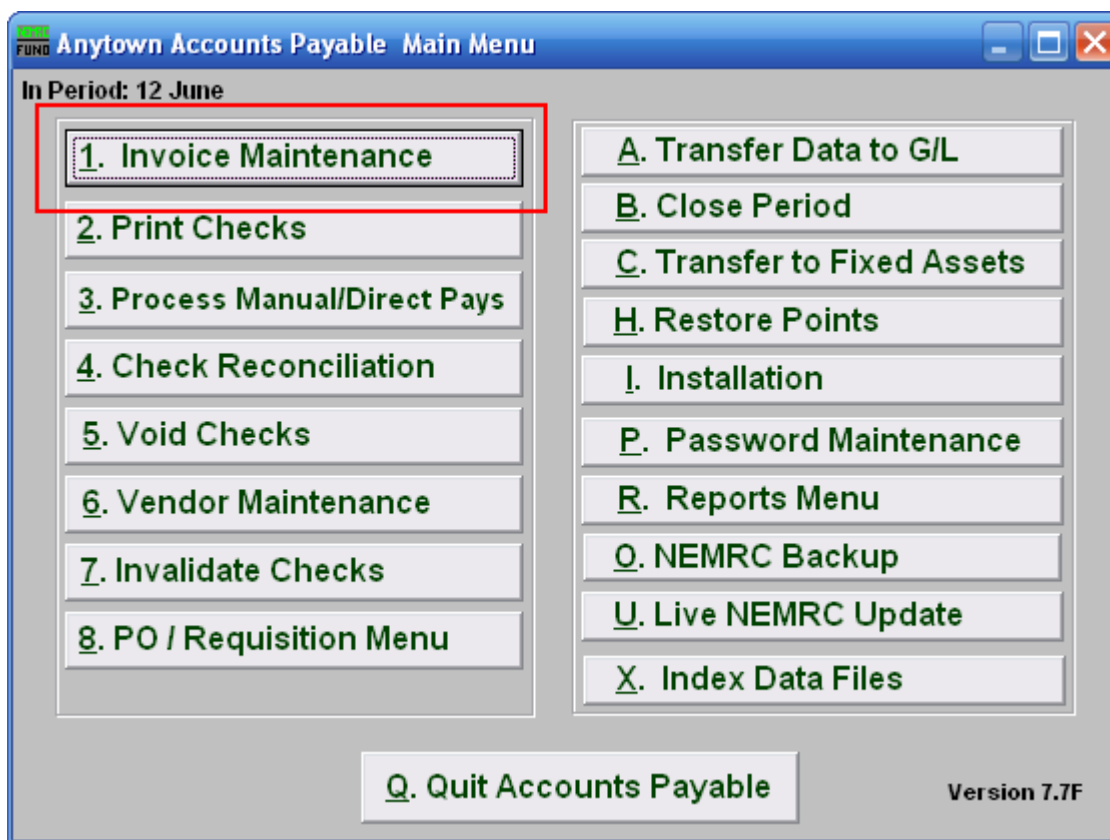

- 1. PO Number:** If you using the Purchase Order System linked to the Accounts Payable you can enter the Purchase Order number and all associated information from the Purchase Order system will be posted on the invoice screen. If the Purchase Order System is not being used then you may skip this field.
- 2. Vendor:** Enter the Vendor for this invoice. If the Vendor already exists in the Vendor file, the company name, address and historical information will automatically appear. Also the credit limit terms and checking account set as a default in Vendor Maintenance will appear. If the Vendor does not already exist, you will need to click “Add,” and the screen from Vendor Maintenance will appear. Fill this screen out with the appropriate information, and click “OK.” For more information on the Vendor Maintenance screen, refer to 6. Vendor Maintenance. For more information on Vendor Lookups, refer to AP GENERAL VENDOR MAINTENANCE.

A warning may appear, this warning is set in “6. Vendor Maintenance” using the “Invoice/PO Warning Memo” option.

Another warning may appear indicating that W9 information is blank or expired. This setting can be set in “I. Installation” off the Main Menu.

Accounts Payable

The “Invoice” tab

This is the first screen that appears. The invoice screen allows the user to enter all information about the invoice and will have any default information that was set up in Vendor Maintenance and historical information about the Vendor.

1. **PO Number:** Enter the reference number for manual purchase orders if used. If you referenced a system purchase order then this field is not accessible.
2. Fields are automatically filled in.
3. **Edit Invoice Address:** Click this button if you wish to change the address for this invoice payment. Each unique invoice address will result in a unique check printing. This is common when Vendor payments must be sent to different locations. A previously used address can be selected from the drop down that appears next to the company name field.
4. **Separate Check:** Click on this button to set this invoice to print a separate check when paid. Some vendors want each invoice to be paid by individual checks.
5. Fields are automatically filled in.
6. **Credit Limit:** This field shows the total credit limit from Vendor maintenance.
7. **Available:** This field shows the available credit from Vendor maintenance.

8. **%:** This shows the percentage discount from Vendor maintenance.
9. **Days:** This shows the number of days allowed from discount payments from Vendor maintenance.
10. **Net Days:** This shows the terms for net payment from Vendor maintenance.
11. **COD:** This shows if the Vendor is defaulted for cash on delivery from Vendor maintenance.
12. **Manual/Direct Pay:** This shows if the Vendor is defaulted for manual/direct pay from Vendor maintenance.
13. **Check Acct:** This shows the default checking account from installation maintenance set for this Vendor.
14. **Invoice: For a new invoice:** Enter the invoice number from the Vendor's invoice. You must enter an invoice number; if none is on the Vendor's invoice you must create an invoice number. For example 2007-12-31 the date of the invoice. The same Vendor code can not have the same invoice number used twice. **To edit an existing invoice:** Enter the invoice number you have already posted for this Vendor, you may use the drop down menu to select the existing invoice number.
15. **Voucher:** If your organization uses voucher numbers, input that number in this field.
16. **Check Acct:** Enter the checking account code (as set up in "I. Installation") that will pay this invoice. Use the drop down menu to view choices of the different checking account codes that have been set up.
17. **Manual/Direct Pay:** An "N" in this box will print the check for this invoice through the check printing process. A manual/direct pay would be an electronic or handwritten check. If this invoice is a manual/direct pay a "Y" should appear in this box. An example of a manual/direct pay would be the IRS; You do not write a check to the IRS however, you approve the money being withdrawn from your account to pay your tax liability. There are very few handwritten checks in most municipalities or schools but an example of a manual/direct pay is a check to the post office for postage. Once again, in Vendor Maintenance you may set this up as a default for any invoice that will be posted with this Vendor code.
18. **Last Year Invoice:** When checked, this invoice will be booked to last year as a reference account in Accounts Payable.
19. **Date:** The actual date of the invoice.

- 20. Due date:** The due date is a method of selecting bills to be paid. Enter the date the invoice will be approved for payment. Be sure to follow your policy for scheduling payments.
- 21. Amount:** Enter the gross amount for this invoice.
- 22. Description:** A description entered in this field will appear on a check warrant report to provide more detail about services rendered.
- 23. %:** This will default to the terms set up in Vendor Maintenance.
- 24. Days:** This will default to the terms set up in Vendor Maintenance.
- 25. Net Days:** This will default to the terms set up in Vendor Maintenance.
- 26. 1099:** This will default to the terms set up in Vendor Maintenance. You may edit this field. Enter “Y” for yes to accumulate for 1099 calendar year totals or “N” to not accumulate for 1099 calendar year totals.
- 27. Fixed Asset:** Click this box to allow this invoice to be transferred to the Fixed Asset module when linked in Installation Maintenance.
- 28. Discount:** Enter a discount amount if applicable.
- 29. Open Vendor:** Click this button to open this vendor in “6. Vendor Maintenance.”
- 30. Save Invoice:** Click this button to save this invoice.
- 31. Cancel:** Click “Cancel” to cancel and return to the Main Menu.

The “General Ledger Reference Accounts” tab is used to input General Ledger account number(s) that total to the amount due on the invoice screen.

- 1. Account:** Enter the General Ledger reference account for payment of this invoice. Multiple accounts may be used by entering one line at a time.
- 2. Description:** The account number description from the General Ledger will appear in this column for each line.
- 3. Amount:** Enter the dollar amount of the invoice that is allotted for each General Ledger account number.
- 4. Disencumber:** If you are using the purchase order system the amount to disencumber will appear. If you have encumbered an account in your General Ledger through posting transactions, enter the amount you wish to disencumber for this line item.
- 5. Discount:** The discount amount will be displayed from the invoice screen, edit this field if you are using several General Ledger accounts and you will spread the discount between those accounts.

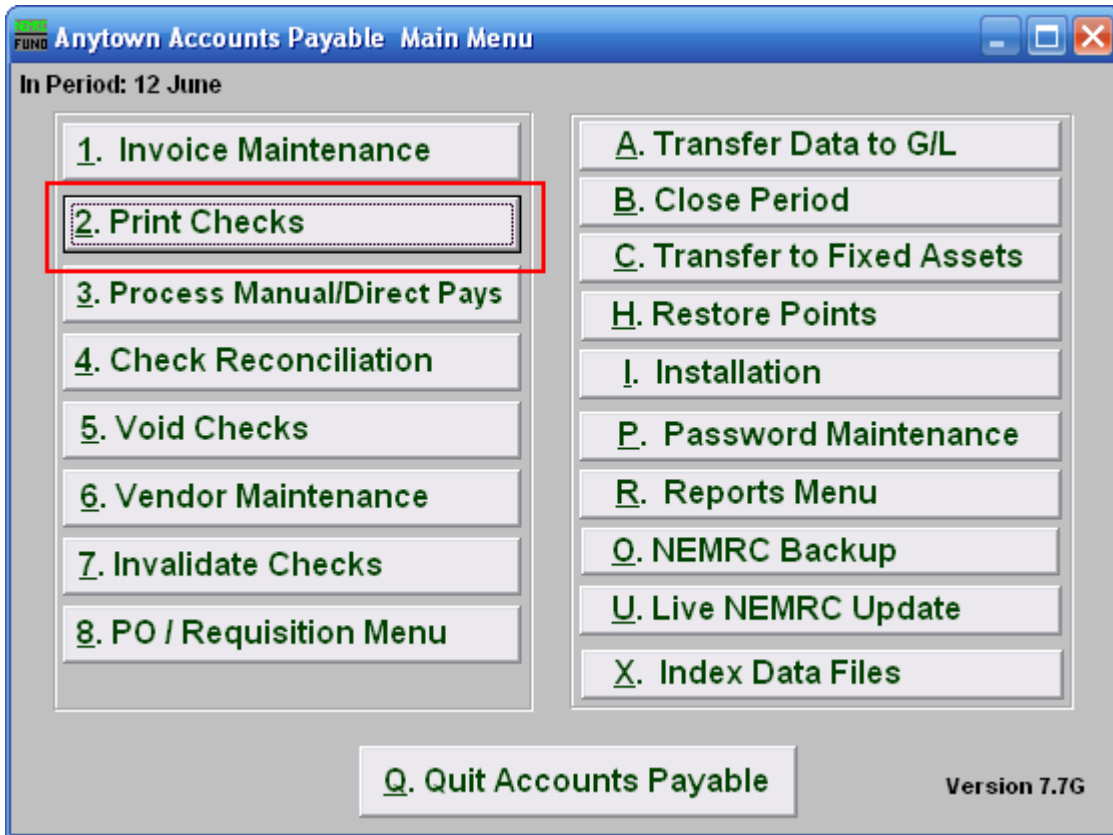
- 6. Add:** Click this button to add additional General Ledger accounts to be referenced for this invoice.
- 7. Delete:** Select a line with a reference account and click this button to delete the reference from this invoice.
- 8. Invoice Amount:** This field shows the total invoice to be distributed.
- 9. Discount:** This field shows the discount amount to be distributed.
- 10. General Ledger Split Amount:** This field shows the amount of the total invoice that has been distributed.
- 11. G/L Discount:** This field shows the amount of the discount taken that has been distributed.
- 12. TOTAL Remaining to Classify:** This will be zero when the referenced amounts equal the amount entered in the invoice tab.
- 13. Remaining:** This field shows the remaining amount of the total invoice that needs to be distributed.
- 14. Cancel:** Click this button to cancel this invoice entry and remove the invoice from the system.

- 4. Create an ACH file:** Check this box after performing step 3 to create the ACH file. A window will appear allowing you to save this file in a location of your choice.
- 5. Edit ACH Parameters:** Click this button to edit the ACH parameters, the window shown below will appear.
- 6. OK:** You must check off item 4 to produce an ACH file if needed before you click on this button. Click this button to save and return to the previous screen.

- 1. Immediate destination DFI:** Enter your banks routing number in this field. Some banks prefer you enter your organizations Federal ID number.
- 2. Immediate destination Name:** Enter the name of your bank.
- 3. Originating DFI number:** Enter your banks routing number in this field.
- 4. Originator name:** Enter the name as it appears on your bank account.
- 5. Originator misc information:** Enter information to help is identifying this batch. This can be left blank.
- 6. Description of transactions:** Enter information to help in identifying this batch. I.E. WARR080304. This should not be left blank.
- 7. Your bank's DFI number:** Enter your banks routing number in this field.
- 8. Your checking account number:** Enter your check account number assigned by the bank.
- 9. Use batch control records?:** Batch control record use is dependant on your bank and their application processing needs. This option will default to the last answer selected.

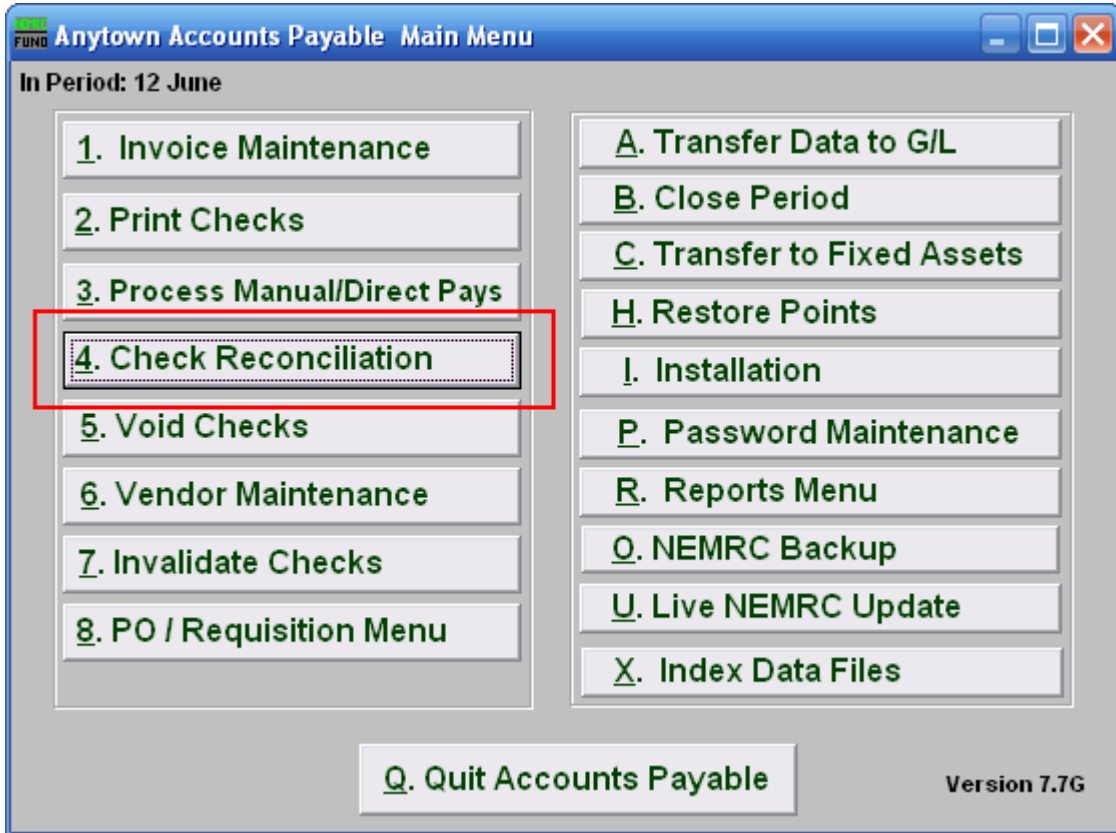

- 1. Diskette Reconciliation:** If your bank provides a diskette of cleared checks and you have defined the positions for check numbers and amounts then item **3** will become available. The information will appear here. **If you do not have a diskette** you will need to go to the checks tab and manually reconcile each individual check.
- 2. Show Mismatches:** Click this button after you’ve reconciled to report a list of checks cashed for amounts other than expected or checks cashed that are not on file.
- 3. Reconcile Diskette Now:** Click this button after establishing the setting from item **1** to begin processing data from a diskette provided by the bank.
- 4. Cleared Checks:** This is informational to track how many have been marked and their total values.
- 5. Save:** Click this button to save the reconciliation of checks in the check file.
- 6. Report:** Click this button to choose an output option for a report of what you’ve just done.
- 7. Cancel:** Click “Cancel” to cancel and return to the previous screen.

- 1. Check Form:** NEMRC has many built in check forms. Consult support for guidance in selecting the correct check form for your organization.
- 2. Prenumbered?:** Check whether you checks have pre-printed numbers assigned on the them. This is standard but not required with NEMRC.
- 3. Link to Fixed Assets:** Accounts payable invoices used to purchase fixed assets can be captured and transferred to that module to save data entry.
- 4. Link to General Ledger:** All activity can be posted to the general ledger when this link is turned on. This is commonly turned on.
- 5. Entity:** This item determines which set of general ledger files to post the entries when the link is turned on.
- 6. Check for Overspending Budget:** The system can test the budget balance in the general ledger during invoice entry and warn if budget will be exceeded.
- 7. Transfer detail to General Ledger:** Postings to the general can be done in cumulative value mode or invoice/check number detail reference.

- 8. Allow Last Year New Invoice:** Selecting “Yes” will allow the creation of a new Invoice dated for the previous year.

- 1. Purchase Order Form:** Enter the purchase order form number that was assigned to you by NEMRC. Most common is a custom form 98. Other options can be discussed with NEMRC support.

- 10. Freight on Board (FOB):** Enter the default location for shipping calculations to appear on the purchase order. This can be changed on each individual purchase order during entry.
- 11. Freight:** Define the default carrier of choice if it must be trucked. This can be changed on each individual purchase order during entry.
- 12. Ship Via:** Type in the shipping method for this purchase order.

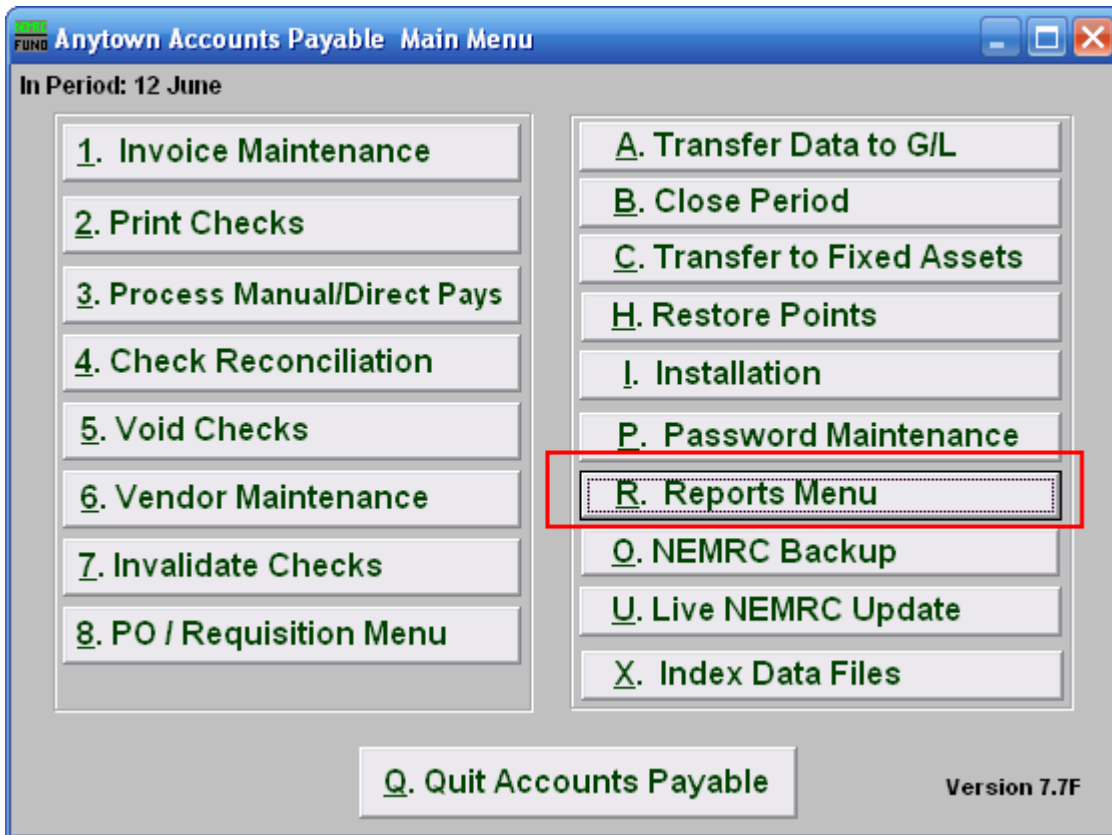

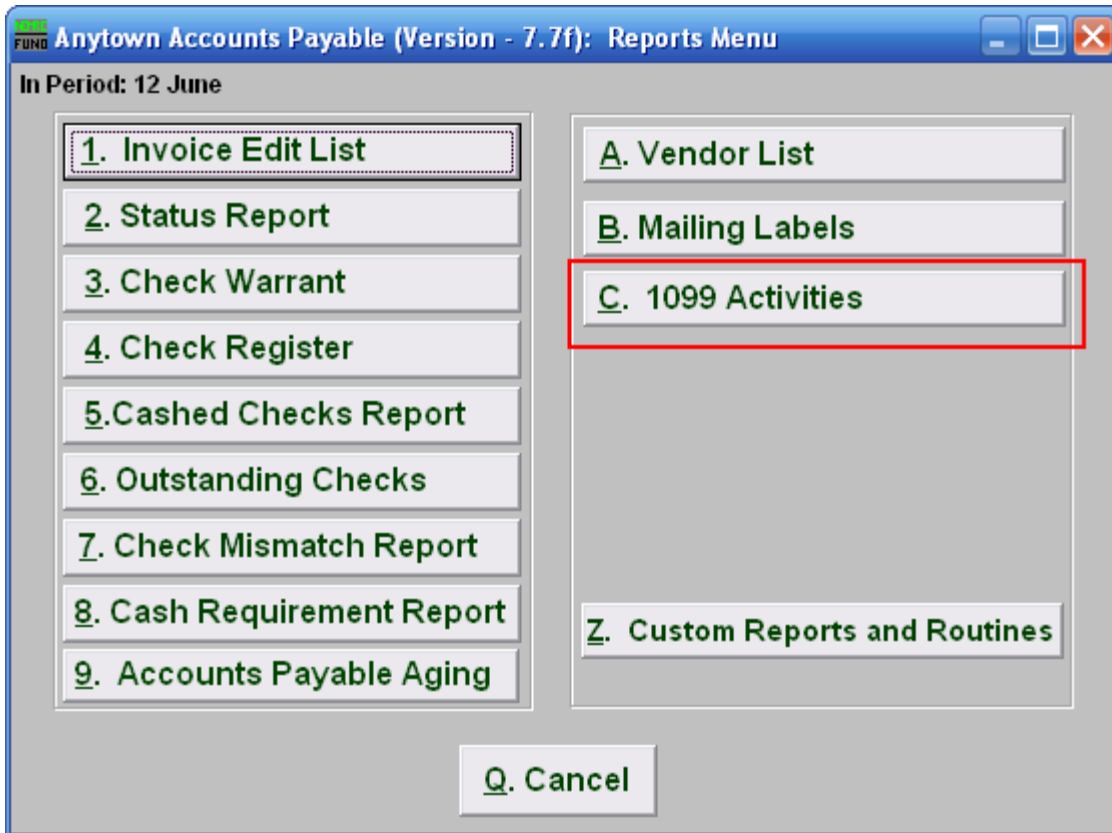

- 1. Current Year Vendor Data OR Last Year Vendor Data:** Select which value from the vendor file to report. 1099's are usually printed after you have closed the calendar year.
- 2. Use \$600 limit OR Print 1099's for all vendors:** There is an option to not print or report on vendors who total is less than \$600.00 in a calendar year offered by the IRS. The default is to print for all vendors with a value.
- 3. Detail Proof Sheet OR Summary Proof Sheet:** The detail version will include all information for each vendor for verification. The summary will provide a total of all vendor amounts on one page.
- 4. Continuous 1099s OR Laser forms Copy A/B/C:** The program will print to continuous feed dot matrix printer forms or the three distinct laser forms required for distribution. Be sure to select the proper laser form letter during printing.
- 5. Laser Vertical Line Offset:** There is an ability to adjust the position across the form in which the print lands because each laser printer does not line up forms the same. Positive values move the position down (1 = 1 line down), and negative values move the position up (-1 = 1 line up).

- 6. Horizontal Line Offset:** There is an ability to adjust the position up or down the form in which the print lands because each laser printer does not line up forms the same. Positive values move the position to the right (1 = 1 character position to the right), and negative values move the position to the left (-1 = 1 character position to the left).
- 7. Vendor (Blank for All):** This option is commonly used when a re-print is required for an individual or range of vendors. Enter the vendor code or click find to select the vendor to start printing from.
- 8. to:** If you used item #7 then enter the vendor code or click find to select the vendor to end printing on.
- 9. Assume current calendar year is:** The value is printed on the 1099 as a reference of what calendar year is being reported.
- 10. Run test and report:** This report will provide the vendors with checks, invoices or vendor file values for reporting. This can be used to determine if some information is inaccurately going to be reported. Values from the vendor file are what will be used on the 1099 forms.
- 11. Print 1099's:** Click this button when you are ready to print the forms selected with the options from above. The first form will print and offer a chance to check the alignment. If adjustments are needed then you can cancel, change the settings and start again.
- 12. Preview 1099's:** Click this button to display the information that would actually print on the 1099s.
- 13. Print 1099 Proof Sheet:** Click this button to print the proof sheet according to the chosen selection of **3**.
- 14. Preview 1099 Proof Sheet:** Click this button to display the proof sheet according to the chosen selection of **3**.
